CONSTITUTION OF THE HIGH COURTS (JUDICIAL COMMISSIONERS) ORDER 2007

IN exercise of the powers conferred by Clause (1) of Article 122^{AB} of the Federal Constitution, the Yang di-Pertuan Agong acting on the advice of the Prime Minister, after consulting the Chief Justice of the Federal Court, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Constitution of the High Courts (Judicial Commissioners) Order 2007**.

(2) This Order is deemed to have come into operation on 13 August 2007.

Appointment of Judicial Commissioners

2. Encik Azman bin Abdullah, Dato' Hinshawati binti Shariff, Tuan Haji Mohd. Yazid bin Haji Mustafa, Tuan Haji Zainal Azman bin Ab. Aziz, Puan Yew Jen Kie, Dato' Ahmadi bin Haji Asnawi, Encik Zamani bin A. Rahim and Encik Ong Lam Kiat Vernon are appointed to be Judicial Commissioners for a period of two years with effect from 13 August 2007.

STATUTORY BODIES (DISCIPLINE AND SURCHARGE) (AMENDMENT OF SECOND SCHEDULE) ORDER 2007

In exercise of the powers conferred by subsection 23(1) of the Statutory Bodies (Discipline and Surcharge) Act 2000 [*Act 605*], the Prime Minister makes the following order:

Citation

1. This order may be cited as the **Statutory Bodies (Discipline and Surcharge) (Amendment of Second Schedule) Order 2007**.

Amendment of Second Schedule

2. The Second Schedule of the Statutory Bodies (Discipline and Surcharge) Act 2000 [*Act 605*] is amended—

(a) in subregulation 6(2), by inserting after the word “certifies” the words “in the form as prescribed in the Schedule”; and

(b) by inserting after regulation 54 the following Schedule:

- (c) he/she is not a drug dependent as defined in the Drug Dependents (Treatment and Rehabilitation) Act 1983 or a drug used of any drug that is listed in the First Schedule to the Dangerous Drug Act 1952.
